



# Privacy Policy

When you visit a website owned by Topcon America Corporation or its affiliates (jointly, "Topcon"), Topcon may obtain information about you. This Privacy Statement explains how Topcon gathers and uses any such information.

## **What information does Topcon collect?**

You are under no obligation to provide any personal information to Topcon. However the information Topcon learns from customers helps us personalize and improve the experience at Topcon's websites. If you don't provide such information, some features of Topcon's websites may not be available to you.

Topcon collects certain types of information whenever you interact with us. For example, Topcon uses "cookies", and obtains certain types of information when your Web browser accesses a Topcon website. We also receive and store any information you enter on a Topcon website or give to Topcon in any other way.

Topcon may request and/or collect certain personal information from you; for example your name, address, email address, telephone number, etc., as well as information related to customer satisfaction surveys, customer purchasing habits, warranty information and/or other purchasing information or other information volunteered by you. Topcon may also collect other technical information such as your IP address, MAC address, internet service provider, computer operating platform, web browser, and other similar information.

## **How does Topcon use this information?**

Topcon may use this information for purposes such as:

- personalizing your experience at our websites;
- selectively sending you information that may be of interest to you;
- contests and sweepstakes;
- market research and on-line surveys;
- contacting you about warranty, service and sales issues; and
- automatic monitoring of statistical information to determine how Topcon's web sites are being used.

In addition to the above, Topcon will provide your personal information to the extent required in, or in connection with, any legal proceeding. Topcon also releases account and other personal information when we believe such release is appropriate in conjunction with Topcon's website Terms of Use and other agreements or to protect the rights, property or safety of Topcon's websites, our users or others. This includes exchanging information with others for fraud protection and credit risk reduction.

We currently do not knowingly collect or use individual identifying information from children under the age of 13, and we will not do so in the future without first obtaining verifiable consent from a parent or legal guardian. Should a child whom we know to be under the age of 13 send individual

identifying information to us, we will only use that information to respond directly to the child, seeking parental consent or to provide parental notice.

### **Does Topcon share the information with third parties?**

We do not sell your personal information to third parties. Topcon may share personal information with business partners in order to improve your experience with Topcon and for Topcon's marketing purposes. Topcon may share non-personal aggregate data about sales, customers, visitors to the site and related site information with third parties.

### **How do I stop Topcon from contacting me via e-mail in the future?**

If you have previously subscribed to one of Topcon's mailing services and now you no longer wish to subscribe for such mailings, you may unsubscribe from such mailing lists on the same webpage where you subscribed.
